After checking in and grabbing a cup of coffee, attendees at Saturday's Presbytery meeting toured the Marie Blanchard Friendship Clinic. This free clinic offers healing ministry to people who cannot

otherwise afford healthcare. Housed in All Saints Episcopal Church, the clinic opened its door 19 years ago, with the vision of member and retired nurse Marie Blanchard. Now 98 years old, Marie Blanchard continues to serve on the board of the clinic. Yvonna Rowett (Interim Exec. Dir.) and Rev. Joseph Farnes (Rector and Ecumenical & Interreligious Officer for the Episcopal Diocese of ID) spoke to us about the mission of the clinic, its ongoing collaboration with the congregation and diocese, and the need for volunteers and donors. 
New Policies

We approved a new 12-week family leave policy applicable to installed pastors and recommended for all. The Presbytery considered a draft of a new dissolution policy, but referred it back to COM for further review.

In Other Business

The Presbytery also:

- set 2024 meeting dates for February 10, May 9, August 8, and November 2;
- approved a Facility Use Agreement for Covenant
- granted a waiver on elder & deacon term limits for King Hill and Weiser churches
- began the transfer of Rev.
 Paul Phillips to National
 Capital Presbytery
- approved a Family Ministry staff position at First (Boise)
- elected officers, trustees, & committee members



Boise Presbytery: Actions Taken Supporting Regional & Local Mission

Noting that we have work to do in the coming years to balance our budget, the Presbytery approved the 2024 budget. It includes congregational grants totaling 11,020, support for our collective ministries as the Presbytery, and Camp Sawtooth support that we share with Kendall Presbytery.

During the Financial M'gmt Committee report, Andrew Kukla expressed gratitude to Ron Abbott, our Presbytery Treasurer who is completing his second term this year. Andrew noted that an abacus is on its way to Ron, along with a more substantial token of our deep appreciation for his service.



Synod Transitions Task Force: Yes, And!

The Synod Transitions Task Force led a "Yes, and…" exercise for table conversation on two questions: how could the Presbytery be a catalyst for connection; and what could we do with Eastern Oregon & Kendall Presbytery as intentional ministry partners.
